He understands the federal procurement process and is expert in articulating capabilities, matching them to requirements and introducing ideas and deployable solutions to the customer and end user. Jeff has a vast network throughout the US Government, industry, and academia to ensure technologies and capabilities are recognized by the customer community as available resources and solutions to current requirements and future challenges. RADM Morneau retired in November 2016 as Commander of the 20,000 Sailors and 138 commands which comprise the United States Navy's Expeditionary Combat Forces, Navy Expeditionary Combat Command and Navy Expeditionary Combat Command Pacific, and the senior EOD and Diving Officer in the United States Department of Defense from 2013-2016. In retirement, he now works as a Senior Strategic Advisor for Strategos Consulting LLC. Frank has extensive experience in DoD leading large, complex organizations and multiple, tactical operational military commands; managing considerable financial accounts; and developing senior executives. Over his last 4 years on active duty, he conceived, developed, and instituted the expansion of EOD Mine Countermeasures (MCM) Platoons into Expeditionary Mine Countermeasures (ExMCM) Companies with the addition of the MK 18 unmanned underwater vehicles into an Unmanned Systems Platoon, and Data Analysis Cell. Frank also served as the Chief of Technology Requirements and Integration for the Joint Improvised Explosive Device Defeat Organization, directing all technology efforts, resourcing, and operational fielding of over 112 innovative, counter Improvised Explosive Device technology initiatives worth more than \$5.5B to counter IED use in global terrorism and as a weapon of strategic influence. RADM Morneau received a Master of Science in National Security Strategy from the National War College in 2006 and is an alumnus of the Massachusetts Institute of Technology Seminar XXI Program, and Naval War College Coalition Force Maritime Component Commander and USN Flag Level Joint Force Maritime Component Commander Courses.

Chuck Leonard, (Vice President of Special Programs): Retired USN Explosive Ordnance Disposal Master Technician with 33 years of experience in Special Operations, and the Joint Service environment including service on ballistic missile submarines, in satellite communications centers, with SEAL and EOD Teams. His ability to see patterns quickly, penchant for innovation, persistence, and need for constant improvement will contribute greatly to any organization. Throughout his career he filled critical positions as SME at Naval Satellite Operations Center (NAVSOC) Detachment Charlie in Agana, Guam where he planned the construction, testing, and validation of a new station responsible for the upkeep and maintenance of the Nations' communications and Global Positioning System (GPS) satellites. He also was assigned to Naval Special Warfare Development Group (NSWDG) in 2011 where he conducted specialized research and development of Counter Weapons of Mass Destruction (CWMD) and Chemical, Biological, Radiological, and Nuclear (CBRN) defense processes and technologies, as well as conducting multiple combat deployment prior to being assigned to the Joint Special Operations Command (JSOC).
